



## Queensland Country Health Fund - 6 Weeks Free and Gift Card Draw

### Terms and Conditions

#### 1. Promotion Period

Offer available for new policy owners who purchase one of the following eligible Queensland Country Health Fund branded hospital only or combined covers issued by HBF Health Limited trading as Queensland Country Health Fund (ABN 11 126 884 786) (**QCHF**) between **9:00am (AEST) on 5 May 2026 and 11:59pm (AEST) on 30 June 2026**.

#### 2. Eligible Covers

- a. Better Hospital (Silver+);
- b. Better Hospital (Silver+) and Extras packaged cover;
- c. Signature Hospital (Silver+)
- d. Signature Hospital (Silver+) and Extras packaged cover;
- e. Vital Hospital (Bronze+);
- f. Vital Hospital (Bronze+) and Extras packaged cover

#### 3. Exclusions

The offer does not apply to:

- employees of QCHF or HBF Health Limited.
- employees of Queensland Country Bank Limited, QCHF's agents, or any of their related entities.
- current or former members who have received a one month free, four weeks free, six weeks free, eight weeks free, ten weeks free or twelve weeks free offer in relation to Queensland Country Health Fund branded cover in the last 18 months.
- a person who has been a member within the last month or who holds current coverage under any Queensland Country Health Fund branded cover either as a spouse or de facto, except where the person was previously insured as a dependent under a family policy and is now purchasing a policy in their own right.
- a current member of Queensland Country Health Fund who is upgrading or downgrading their cover, adding a spouse or dependant, or making any other policy changes.
- a person who has held cover with HBF Health Limited or HBF Health Limited and has previously received a one month free, four weeks free, six weeks free or eight weeks free offer in the last 18 months.

#### **4. Gift Card Eligibility**

To be eligible to **receive a chance to win** a prize, entrants must satisfy the following criteria:
