

## **Queensland Country Health Fund**6 Weeks Free and Gift Card draw Terms and Conditions

- Offer available for new policy owners who purchase one of the following eligible Queensland Country Health Fund branded hospital only or combined covers issued by HBF Health Limited trading as Queensland Country Health Fund (ABN 11 126 884 786) (QCHF) between 9:00 am (AEST) on 8 September 2025 and 11.59 pm (AEST) on 12 December 2025:
  - a. Better Hospital (Silver+);
  - b. Better Hospital (Silver+) and Extras packaged cover;
  - c. Vital Hospital (Bronze+); and
  - d. Vital Hospital (Bronze+) and Extras packaged cover.
- 2. Offer does not apply to:
  - a. employees of QCHF & HBF;
  - b. employees of Queensland Country Bank Limited, QCHF's agents or any of its related entities;
  - c. current or former members who have previously received a one month free, four weeks free, six weeks free, eight weeks free and 10 weeks free offer in relation to Queensland Country Health Fund branded cover in the last 18 months; or
